

TERMS AND CONDITIONS OF USE

Welcome to *learnsahajayoga.org* (the “Site”). Nirmal Vidya LLC (“NV”), owner of the Site, provides services to you subject to the following Terms and Conditions of Use (“Terms and Conditions”). Please read these Terms and Conditions before using the Site. The Terms and Conditions constitute a binding agreement between you and NV (also referred to as “we,” “us,” and “our”). **By using the Site or using the services provided therein, you agree to be bound by these Terms and Conditions.** If you do not agree to the Terms and Conditions, please do not use the Site or any of the services provided on the Site. Users who violate these terms may have their access and use of the Site suspended or terminated, at the sole discretion of NV.

Modifications
